Chair Ronnie Cruz entertained a motion to table Employee Policy Manual. Commissioner Eliseo "Tito" Salinas made a motion to approve; Vice Chair Elva M. Cerda second the motion. Motion carried unanimously.
- c) Consideration and Possible Action to Approve Amendments to the McAllen Housing Authority's Accounting Policy. Deputy Directory Delgado stated the Federal Government Code of Federal Regulations has increased the micro purchase threshold to \$3,000 for non-construction related purchases. Recommends approval to amend and increase current limit in order to align with the updated CFR regulations. Chair Ronnie Cruz entertained a motion to Approve Amendments to the McAllen Housing Authority's Accounting Policy. Vice Chair Elva M. Cerda made a motion to approve; Commissioner Eliseo "Tito" Salinas second the motion. Motion carried unanimously.

- a) Executive Director's Report
  - Emergency Housing Vouchers (54) were received, will provide assistance for 36 months to people who meet criteria.
  - MHA Newsletter will be coming out quarterly and will be distributed to the community.
  - Ron Vasquez Director of South Texas Coalition has donated books and will be running a summer camp at our Learning Center. The objective is to push literacy and writing, and possibly publish a book on Amazon. All proceeds will benefit the South Texas Coalition.

- b) Financial Summary
  - Consolidated revenue at \$699,000 vs expenses of \$764,00, net income loss of \$64,000 due to adjustments that needed to be corrected.
  - Sec. 8 revenue of \$621,000 vs expense of \$584,000, net income of \$37,000.
  - Low Rent revenue of \$27,000 vs expense of \$40,000, net income loss of \$12,000.
